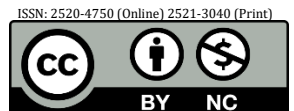

The abstract should be a clear and informative story that disseminates the central message of the study (Herbst et al., 2019). It should also be packed with all essential relevant information about the survey, providing an unbiased and accurate summary (Bavdekar & Gogtay, 2015).

4.1. *Research problem or objective*

The abstract should clearly state the research problem or objective the study aims to address. It helps readers understand the motivation and context of the research.

4.2. *Methodology*

Briefly describe the research methodology, including the research design, data collection, and analysis techniques. It gives readers an idea of how the study was conducted and the rigor of the research.
